I. 24 HOUR PERSONAL ACCIDENT TO THE INSURED

Provides the insured with the following compensation in the event of an accident on any golf club premises:

Death	S\$50,000
Loss of both eyes	S\$50,000
Loss of both limbs	S\$50,000
Loss of one eye	S\$25,000
Loss of one limb	S\$25,000
Permanent Total Disability	S\$300 per week (max 52 weeks)

II. LOSS OF GOLFING EQUIPMENT AND PERSONAL EFFECTS

In the event of loss or damage by Fire or Theft whilst on any golf club premises, the company may at its own option repair, reinstate or replace such loss or damage or pay in cash the amount of the loss or damage up to **S\$3,000**.

Deductible - S\$50.00 for personal effects (excluding watches, jewellery, handphones, trinkets, medals, coins, articles of gold, silver, precious stone, furs, cameras, money, securities or stamps).

III. BREAKAGE OF CLUBS

Pays up to **S\$300** per club, for accidental breakage of clubs during the course of actual play or practice on any golf course.

Deductible - S\$50.00

IV. LIABILITY TO THE PUBLIC

Pays up to **S\$500,000** for accidental bodily injury to third party or accidental damage to property (other than property belonging to or under the control of the Insured) caused by the Insured whilst playing or practicing in any golf course.

Liability amount: up to **S\$500,000** for any one accident

V. HOLE-IN-ONE

If you strike a hole-in-one on any golf course of a recognised golf club, we will pay up to **S\$1,000** for the cost of hospitality (food and beverages), within the same day at the same club.
