Dear Pastors Ray and Sherwood,

Hello Pastors. Enclosed with this letter to both of you is a letter that I have written to Bill Coyne, CEO of Raley's and a professing brother in the Lord. I have written to Bill as mentioned in the letter on numerous occasions with no response at all from him.

After hearing Pastor Raleigh Washington's message on Sunday on "Breaking Down The Walls with Honor" I was prompted to write two letters. One letter was to Bill Coyne and another letter to the both of you. I have heard from other people that Bill Coyne is an "awesome man of God". Maybe outwardly to most people and even financially to Bayside he gives the appearance of godliness. But his lack of action in responding to my family's simple request to resolve this ongoing attempt by Raley's, to lie about my fathers good name, honor and legacy makes me wonder. Pastor Ray, I know you have never sat face to face with my family to hear this incredible story, and we would love to share it with you and Bill Coyne. I realize that Bill Coyne may say this is a legal issue. It is no longer a legal issue and he should not be able to use that "legal issue" loophole to avoid the real issues at hand which are truth, honesty, moral ethics and righteousness (doing the right thing apart from the law) which is expected of true believers.

The only question we want Bill Coyne, CEO of Raley's to answer is: Was it Charles Nordby's retail program or buying the Eagle Thrifty Stores in Nevada that turned Tom Raley's company around in 1973? Our father's entire honor and his legacy are based on this answer.

"Prove all things, hold fast to that which is good."

If he can **disprove** that it was Charles Nordby's program that did it, the \$100,000 reward that is put up by a family member will be split between your two churches, and the Nordby family will put our father's story rest. The proof he must be able to show must be accurate with documentation of facts, not hearsay nor based on Raley's history book.

If he cannot or will not disprove our father's story and legacy then Bill Coyne needs to be corrected in the faith. Scripturally, Bill Coyne's tithes and offerings shouldn't be received until he resolves this matter. Here are the Words of Jesus himself:
