Dear Pastor Ray and Sister Carol,

Today, the crime continues on because Raley's owners Jim and Joyce Raley Teel and now their CEO, Bill Coyne with all their wealth are ignoring this crime against our father, his honor, his legacy, and the truth of their success.

For some reason, no one wants to hold Jim and Joyce Raley Teel accountable for this crime. Is it because they can not believe these people have committed such a crime? Or is it because they have contributed large sums of money to churches and other charitable causes? All their money and success since 1973 are the results from what Charles Nordby did for them. Before he died he publicly declared "I saved their company from bankruptcy and they defrauded me!"

Ray and Carol, have you ever seen the movie "Flash of Genius"? It is about the man who invented the intermittent windshield wiper back in the 60's. The Ford Motor Company stole his idea and took credit for his work. This man did not give up fighting for this truth. It was his life and his greatest success. Our father died in the midst of fighting against this injustice and for the truth of his greatest success. His children now carry on his fight and will not stop until justice prevails.

Pastor Ray, I know that you are a man of truth since you are a man of God. I also believe that you are not a respecter of persons and that getting to the truth of a matter is far more important to you than someone's money or power and the ungodly influence that those two can bring.

I know this letter will reach you, and my family and some of my Bayside friends would love to meet with you and fill you in on this great story of how God used one man to save a company. With your godly instruction, Bill Coyne can redeem everyone involved in this crime against our father. Amen!
