*In consideration for being permitted to participate in the event, I, on behalf of the participant, as the participant's parent or legal guardian, acknowledge and agree to the following:*

**Assumption of Risk:** I fully understand that participation in the event may not only involve risk of serious injury or death, economic loss, property damage, or loss that may result from the participant's own actions, inactions, or negligence, but also from the actions, inactions, or negligence of others, the condition of the facilities, equipment, or areas where the event is being conducted, and I or the participant voluntarily agrees to assume this risk.

**Covenant Not To Sue.** I, or the participant's, my or the participant's personal and legal representatives, heirs, successors, and next of kin will not make any claim against Mile Hi Barrel Horse Association and/or Douglas County, Colorado and/ or any of its present or former officials, employees, agents, attorneys, insurers, and representatives and their respective successors, heirs and assigns or any volunteer(s), for injury, damage, death, or any other loss arising from or related to participation in the event. Further, the participant's personal and legal representatives, heirs, successors, and next of kin will not make any claim against Mile Hi Barrel Horse Association and/or Douglas County, or any of its present or former officials, employees, agents, attorneys, insurers, and representatives and their respective successors, heirs and assigns or any volunteer(s), for injury, damage, death, or any other loss arising from or related to participation in the event.

**Release.** I, or the participant's, my or the participant's personal and legal representatives, heirs, successors, and next of kin, forever release, waive, discharge and relinquish Mile Hi Barrel Horse Association and Douglas County from any and all actions, causes of action, claims, charges, demands, losses, damages, costs, attorney's fees, judgments, liens, indebtedness, and liabilities of every kind and character, whether known or unknown, including foreseen or unforeseen bodily injury and personal injuries and property damage that may be sustained by the participant in any way connected to, related to, or arising out of participation in the event, regardless of any negligence of Mile Hi Barrel Horse Association and/or Douglas County.

**Good Health.** I warrant that I am or participant is in good health and have no physical condition that would prevent me from participating in the event. I have had the opportunity to seek medical advice for any concerns I may have had regarding my health.

**Riding and Participation:** I understand that as a rider in the above mentioned event, I am participating and riding at my own risk and am responsible for any injuries I might incur as the result of my participation.

**Permission to Use Images.** I grant permission for Mile Hi Barrel Horse Association and/or Douglas County to use video and/or photo images of me or the participant for promotional purposes. These images or photo's will be taken at random throughout the event. I or the participant agree not to charge and will not receive any monetary or residual payment for use of the images or photos.

**Statutory Limitation On Liability.** I understand that under Colorado Law, equine professionals or equine activity sponsors are not liable for injury to or death of a participant in equine activities resulting from the inherent risks of equine activities, pursuant to section 13-21-119, Colorado Revised Statutes.

I have no obligation to participate in this event or sign this Agreement, but I desire to do so. I certify that I am at least 18 years of age.*
