

**T**he March 1 article "Jail strip searches recorded on video" quotes Undersheriff John McGinness as saying, "We simply cannot take a chance that weapons, drugs and other contraband will find their way into the jail." I have to wonder why strip searching and visual body-cavity checks aren't routinely practiced at our courthouses, state and federal buildings and so on. Aren't judges, district attorneys and honest citizens more important than those people who find themselves at the mercy of jail attendants?

Let's be honest. Being in jail is demeaning. Having individuals strip in front of others and having body-cavity searches makes the experience even more demeaning. A simple solution to this problem at the jail is for McGinness to install a metal detector for the weapons, and trained dogs to sniff out the drugs and other contraband – a simple solution that retains personal dignity to those who find themselves in jail for whatever reason.
