
**An open letter to terrorist Bin Laden- Blue Collar Terrorist**

## An open letter TO THE PUBLIC

**Why** are American's being asked to boycott these stores? These stores negotiate labor contracts with Jack Loveall. What's the problem with negotiating a labor contract with Jack Loveall? Jack Loveall became president of this Union in the early 80's. However, he has never been elected by the Union membership into his position. He has dishonestly built a lucrative empire for himself, along with giving outrageous high salaries to his family and friends. Jack Loveall is also involved in anti-american activities such as eliminating the election process for it's members. Democracy is a fundamental right for all Americans except the Americans belonging to this Union.

**The U.S.** Department of Labor requires our Union to hold an election every three years. Jack Loveall has been president of UFCW 588 for nearly twenty (20) years, and the members of this union have never had an election ballot for the presidency of this Union offered to them for a vote. By looking at the other side you can clearly see that the size of his and his family's \*salaries are the number one reason why Jack Loveall doesn't want an election. He's afraid that an honest election threatens his empire and his corrupt union. **In 1997**, UFCW 588 sent out a notice to all the members stating that election nominations for the President and officers of this Union were being held. The U.S. Department of Labor requires the Union to do this. A member of the Union put his name forward to have his name placed on the ballot. The Union bylaws in 1997 required a member to obtain signatures of 1% of the total number of active members of the union (217 signatures needed), to have their name placed on the election ballot. When Jack Loveall and his Union thugs became aware that there was an active member out seeking the needed signatures, he did everything he could to prevent this member from opposing him. **Read on**, it gets a lot more exciting.

**This member** was chased around town in his vehicle by Union thugs in their vehicles, which was recorded on video tape, to intimidate him. He was assaulted going into a Lucky store where he wanted to obtain signatures. This member's family members were also intimidated where they lived. At one point (caught on video tape), a union thug is witnessed backing up his car on the (busy) Watt Ave, with oncoming traffic, to chase this member down the street where this member lives. The Union thugs even terrorized this member's family while driving down Sacramento streets to attend the Church that he and his family belonged to (on a Sunday). All in the name of "Jack Loveall Democracy". **This member's two young daughters were terrorized by this incident.** When Jack Loveall and his Union thugs realized that these tactics weren't going to succeed, he decided to go to the active members that had placed their signatures on a petition to have an election and had many of these members remove their names from this nomination petition. **Jack Loveall** was even able to intimidate members during this process. All in the name of democracy. When this member went to the U.S Department of Labor for assistance, the Government basically said that the members weren't entitled to an election and that it was OK for children to be terrorized by anti-American people like Jack Loveall.
